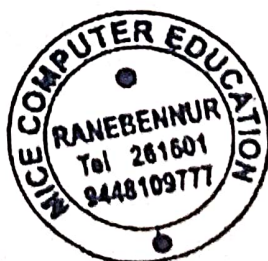

THIS MEMORANDUM OF UNDERSTANDING ('MOU') is made at Hubli, Karnataka, India on this _____ (Date) by and between:

Deshpande Educational Trust, a charitable trust incorporated under the Indian Trusts Act 1882, and having its principal office at Airport Road, Hubballi, Karnataka 580030 India, (hereinafter "**Deshpande Skilling**") duly represented by its Chief Operating Officer, Mr. P.N. Navak which expression shall, unless it be repugnant to the meaning or context thereof be deemed to mean and include its successors and assigns

AND

"SJMV BAJSS Arts & Commerce College for Women" having its presence in District Haveri, Pin code - 581115 offering technical diploma / under graduation courses for B.Com, BA, B.Sc., B.Ed., BBA, Diploma represented by its _____ (hereinafter referred to as "**Partner College**"), which expression shall, unless repugnant to the meaning or context thereof, be deemed to mean and include its successors and permitted assigns)

AND

DESHPANDE SKILLING and **The PARTNER COLLEGE** are hereinafter collectively referred to as '**Parties**' and individually as a '**Party**'.

WHEREAS:

1. **DESHPANDE SKILLING** a "**not for profit**" trust, an impact unit of **Deshpande Foundation, India**, and a training partner of **National Skill Development Corporation (NSDC)**, involved in the activity of conducting residential employability skills training programs for graduates of rural and semi urban colleges at its skilling campus in Hubballi, and providing placement assistance to its students. **Deshpande Skilling** is desirous to bring about rural transformation by building employability skills among graduate youth from rural and semi urban colleges and assist them earn their first employment in the formal sector. **Deshpande Skilling** wishes to admit job seeking students who pass out of college, but have failed to acquire the required skills to earn employment to its skilling program.

FOUNDATION will support by skilling and placing students of the PARTNER COLLEGE and enhance its placement rate.

11. DESHPANDE SKILLING will work with the PARTNER COLLEGE to build a mindset of preparing early to earn a placement and start career among select students of the partner college. The 2 parties will agree on an annual activity calendar that could include group counselling and Q&A session, interaction with Alumni of the college who have been successful, remote classes for students, and any other activities that could give students awareness and exposure.
12. DESHPANDE FOUNDATION will also extend invitation to staff of the PARTNER COLLEGE to attend trainings and workshops that it will conduct on Skills Development for employability and other such areas that can contribute to enhancing placement record of the PARTNER COLLEGE.


The Parties are therefore entering into this MOU to record the terms and conditions of this collaboration. **DESHPANDE SKILLING** and **THE PARTNER COLLEGE** have agreed to enter into this MOU to record their present state of agreement in principle in respect of the **UBER College Partnership Program**.

NOW IT IS HEREBY MUTUALLY AGREED BY AND BETWEEN THE PARTIES AS FOLLOWS:

This collaboration between DESHPANDE SKILLING and THE PARTNER COLLEGE will be to impart skill training and provide placement assistance to select students of "THE PARTNER COLLEGE" to be able earn their first employment. The objective of this partnership is to facilitate rural transformation by getting rural youth into productive employment, and to enhance the placement record of the partner college.

Roles & Responsibilities of PARTNER COLLEGE:

1. Party would enter in MOU for the DESHPANDE SKILLING's "**UBER College Partnership Program**" for Skill development Training for interested students of The PARTNER COLLEGE.
2. PARTNER COLLEGE will support the program by recommending about 30 most suitable students of the college each year for the residential skilling program for graduate students conducted by DESHPANDE SKILLING at its Skilling campus.
3. PARTNER COLLEGE will recommend students from BA / B.Com/B.Sc. / BBA / BCA / B.Ed. / Technical Diploma / ITI streams only.
4. PARTNER COLLEGE will apply adequate justification for recommendation of each student for admission. The recommendation will be an informed decision that the

4. DESHPANDE SKILLING will provide the skill training to students of the partner college at its residential skilling facility as per academic plan of the specific program into which they are admitted.
5. DESHPANDE SKILLING will offer placement assistance to students of the Partner College admitted to its skilling program. Every student will be provided with multiple opportunities for placement process of different companies.
6. DESHPANDE SKILLING will with employer organizations to understand current and future skill requirements of employers and also to invite employers to provide opportunity to fellows of the skilling program for openings in their organizations.
7. THE PARTNER COLLEGE will be branded in DESHPANDE SKILLING's program website and other relevant platforms which are viewed by community of employers.
8. DESHPANDE SKILLING will provide updates about the progress of students of the partner college to the placement officer and principal of the partner college. The partner college will also be updated about the job offers received by its students.
9. DESHPANDE SKILLING retains its right to charge the students skill trainings.
10. DESHPANDE SKILLING will communicate that the partner college can extend to its financially challenged students during the first week of January each year.
11. DESHPANDE SKILLING will provide training completion certificates to all such students who have successfully completed the training. The certificate will bear the logo of NSDC and DESHPANDE SKILLING.
12. DESHPANDE SKILLING will provide placement assistance to students of the program thru its in-house Placement Assistance Cell or its placement partners.
13. DESHPANDE SKILLING will explore non-residential skills training program for diploma students at your premises

All Confidential Information provided or disclosed by either Party here under shall remain the property of the furnishing party, and shall be held in strict confidence by the receiving Party, unless the furnishing Party otherwise consents in writing or unless disclosure of such Confidential Information is required by the applicable laws.

Any disputes or differences which may arise between the Parties out of, in relation to or in connection with this MoU, or for the breach thereof shall be settled by arbitration. Each Party hereto shall be entitled to appoint 1 (one) arbitrator and the 2 (two) arbitrators so appointed shall appoint the presiding arbitrator. The Arbitration and Conciliation Act 1996 or any statutory modifications shall govern the arbitration thereof. The venue of arbitration shall be at Hubballi, India and language of arbitration shall be English language.

Applicable Law & Jurisdiction

Any action/dispute/claim arising out of or related to this MoU shall be governed by the laws of India and the courts at Hubballi shall have exclusive jurisdiction in respect of all such actions/disputes/claims arising out of this MoU.

Notices

Any notice, or other communication under this MoU shall be in writing and shall be deemed to have been effectively served if sent by personal delivery or courier or by registered prepaid mail and addressed to the Parties at their respective addresses set forth hereinbefore (or at such other address as a Party may specify by notice to the other).

Miscellaneous







